4.2 Most important symptoms and effects, both acute and delayed:

4.2.1 Inhalation: There may be irritation of the throat with a feeling of tightness in the chest.

4.2.2 Skin contact: Skin irritant. Contact may cause redness, itching, burning and skin damage.

4.2.3 Eye contact: Eye irritant. Contact may cause stinging, watering, redness and swelling. Vision may become blurred. May cause permanent damage.

4.2.4 Ingestion: Nausea, vomiting, diarrhoea, abdominal pain, hypotension, haematemesis, fever. Lack of symptoms within the first 6 hours makes significant toxicity unlikely.

4.3 Indication of any immediate medical attention and special treatment needed:

6.3 Methods and material for containment and cleaning up:
