SECTION 4. FIRST AID MEASURES

4.1 Description of first aid measures:

- **4.1.1 Inhalation**: Move affected person to fresh air immediately. Keep warm and at rest in a position comfortable for breathing. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen.

4.2 Most important symptoms and effects, both acute and delayed:

- **4.2.1 Inhalation**: There may be irritation of the throat with a feeling of tightness in the chest.
- **4.2.2 Skin contact**: Skin irritant. Contact may cause redness and irritation at the site of contact.
- **4.2.3 Eye contact**: Eye irritant. Contact may cause stinging, watering, redness and swelling. Vision may become blurred. May cause permanent damage.
- **4.2.4 Ingestion:** Low toxicity. There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur.

Delayed/immediate effects: Immediate effects can be expected after short-term exposure.

SECTION 6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures:

6.2 Environmental precautions:

Avoid pollution of sewers and watercourses. May release ammonium ions that are toxic to fish. Release to watercourses may cause effects downstream.

6.3 Methods and material for containment and cleaning up:

Contain and sweep up spillages. Place unusable material in clearly labelled containers or plastic bags for disposal. Wet residues are slippery, wash floors to remove all traces.
